I am writing to you because your office recently returned to me a copy of the 2002 Annual Report/Uniform Business Report for "Charleen Ramus Jaffe, P.A." for allegedly failing to file a name change. (The company was formerly known as "Charleen C. Ramus, P.A." and is currently known as "Charleen Ramus Jaffe, P.A."). The Articles of Amendment to the Articles of Incorporation reflecting this name change (as well as other matters) were filed on September 17, 2001. A copy of these Articles of Amendment filed on September 17, 2001, is enclosed herewith and reflects a date-stamp of September 17, 2001, by the Secretary of State. (Highlighted in yellow is Article One reflecting the name change of the P.A.). Also enclosed is the correspondence the P.A. received dated September 18, 2001, from the Secretary of State acknowledging receipt of the Articles of Amendment referenced above.

Also enclosed is a copy of the correspondence the P.A. received from the Secretary of State dated March 19, 2002, stating incorrectly that the name of the P.A. had not been changed to the new name and stating that the Annual Report/Uniform Business Report had not been filed as a result thereof. Attached to that correspondence is a copy of the 2002 Annual Report/Uniform Business Report. The \$150.00 check was not returned along with this correspondence so I am assuming that your office has that check in your possession.

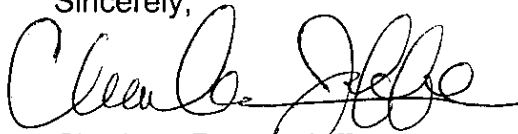
