Dear Ms. Alan,

As discussed in previous correspondence and telephone discussions with your office, I am changing the status of CRISES Press, Inc. this year from non-profit to profit. At the time it was founded in 1991, my intent was to develop the company as a non-profit, 501(c)(3) tax-exempt small publisher in the public interest.

For various reasons, we never actually applied for this status. The company always was, and remains, a one-person operation (namely me). I have regularly filed the for-profit Form 1120 or 1120A each year with the IRS. CRISES Press has always operated at a loss. No federal taxes have ever been due.

In Florida, however, I continued to file the non-profit forms until this year. No taxes were ever due. Now it seems simpler and more straightforward to change the basic status of CRISES Press from non-profit to profit. I have obtained and completed the necessary Transmittal Letter and the Articles of Incorporation, enclosed herewith, with a \$70.00 check for the filing fee. I understand that the former non-profit corporation is automatically dissolved.


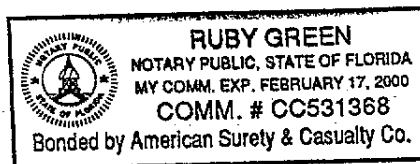
