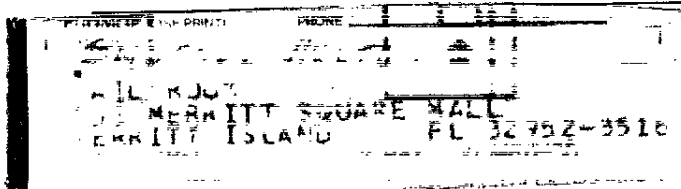

ARTICLES OF INCORPORATION
OF
SYNERGY CENTER OF BREVARD, INC.

ARTICLE I - NAME

The name of this corporation is SYNERGY CENTER OF BREVARD, INC. The registered address of this corporation is 2360 JASON STREET, MERRITT ISLAND, FL. 32953.

ARTICLE II - DURATION

This corporation shall exist perpetually. The date of commencement of the corporation shall be OCTOBER 1, 1997.

EFFECTIVE DATE

10-1-97

ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in any business activity permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of \$1.00 par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.
