ARTICLES OF INCORPORATION

The undersigned natural persons, each of whom is licensed or otherwise legally authorized to practice the profession of law in the State of Florida, hereby associate themselves with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopt the following articles of incorporation for such corporation:

ARTICLE I, NAME

The name of the corporation shall be:

ARTICLE II, PURPOSE

The purpose of the corporation shall be to practice the profession of law.

ARTICLE III, CAPITAL STOCK

The total number of shares of capital stock which the corporation shall be authorized to issue is 1000 shares. Such shares shall be of a single class of common stock, and shall have a par value of One dollar (\$1.00) per share.

ARTICLE IV, CAPITALIZATION

The amount of capital with which the corporation will begin to practice the profession of medicine is not less than One Thousand Dollars (\$1,000.00).

ARTICLE V, DURATION

The Corporation shall have perpetual existence.

ARTICLE VII, MANAGEMENT BY SHAREHOLDERS

ARTICLE IX, DISSOLUTION

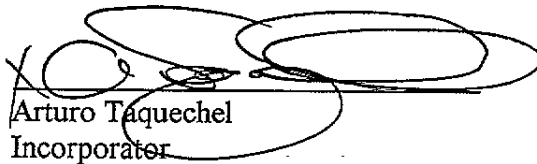
The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least two thirds of the outstanding shares of the corporation entitled to vote thereon.
