In addition, enclosed is a check in the amount of \$300.00 which will cover the filing fees for 2002 and 2003.

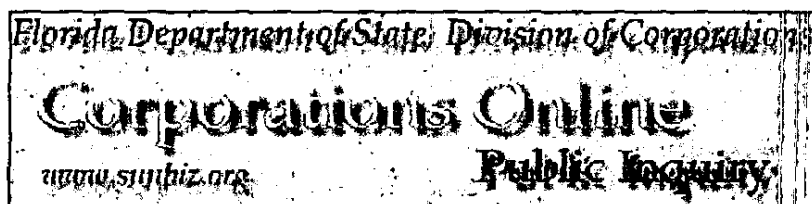
