Article III

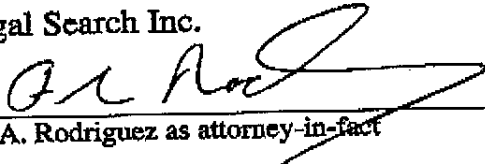
