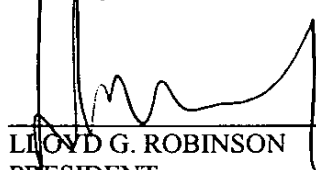
On Tuesday July 05, received a 'Notice of Intent to Dissolve' form in the mail. Please be advised that we did not receive the original notice prior to the first renewal date.
