ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation is Atlantic Investigations & Consultants, Inc.

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE

The corporation is organized for the purpose of conducting investigations, provide consulting services and provide related services in the investigative and security field to individuals, companies and other entities for profit; to do all things necessary and proper for the creation, startup and maintenance of a business to effect the purposes of this corporation; to buy, sell, pledge, repair and maintain any and all equipment and property necessary and proper to effect the purposes of this corporation; to do any other lawful act under the laws of the State of Florida and the United States of America.

ARTICLE IV

CAPITAL STOCK

The aggregate number of shares of stock which the corporations has authority to issue is 300, all of which shall be common shares with a par value of \$1.00 per share.
