This corporation is organized for the sole and specific purpose of rendering services within the State of Florida.

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

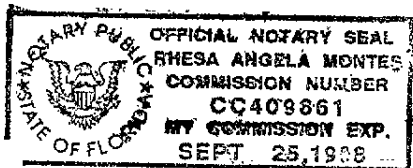
