In January, 2002, I decided there was no way to rectify this problem other than to change my official business addresses for my various businesses located in the physical address of my dental practice to a post office out of this area. Accordingly, I opened post office boxes in Ponte Vedra Beach, and have been systematically changing the official mail/billing addresses to those P.O. Boxes. To compound the issue, the local Post Office Branch has "lost" much, if not most, of my mail that was being addressed to the physical address. Some of this mail does find its way into my local Post Office Box, but the majority of it gets places, as I have been told by the post office personnel, in their "suspended" file, never to be seen again.

Just by chance the mailings for the reinstatement made it through the system and was ultimately delivered to my P.O. box in March, 2002 --- I have no way of knowing when it was actually placed in the mail. It is not uncommon for me to receive some scattered pieces of mail literally months after postmarks.

As you will notice, I have recorded my change of address information on the reinstatement notices that are included in this mailing and hopefully, this will correct this problem, at least from the Division of Corporations aspect.

My request is to receive consideration on the penalty fees assessed based on this explanation of extenuating circumstances.

I have returned my forms enclosed herein along with my check of \$150 for each corporation listed herein. If there are any additional charges levied necessary to reinstate the two entities, please notify me and I will remit accordingly.
