ARTICLES OF INCORPORATION
OF
SOUTHSIDE LAWNS, INC.

ARTICLE I - NAME AND MAILING ADDRESS

The name of this corporation is Southside Lawns, Inc. and the mailing address is: 3617 E. Royal Palm Circle, Tampa, Fl. 33629.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.


ARTICLE XIII - AMENDMENT


