ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is Plowboys, Inc. and the address is 217 West 6th Avenue, Mount Dora, Florida 32757.

ARTICLE II - TERM OF EXISTENCE

This Corporation shall exist perpetually.

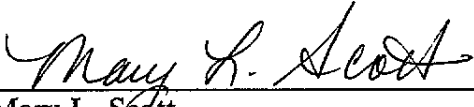

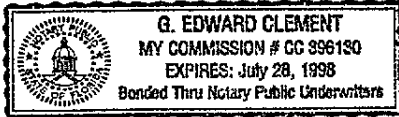
