RESTATED ARTICLES OF INCORPORATION

Article I - Name

The name of this corporation is FLORIDA HOME BUILDERS INSURANCE STATE INC.

Article II - Business

The corporation shall have the power to conduct all lawful business under the laws of the State of Florida, and to do all things necessary or convenient to carry out its business and affairs.

Article III - Capital Stock

The corporation shall be authorized to issue Five Hundred (500) shares common stock.

The corporation shall have no less than 13 directors. The number of directors may be established, increased, or decreased from time to time by amendment to the corporation's bylaws adopted by the stockholders.
