ARTICLE VIII. PREEMPTIVE RIGHTS.





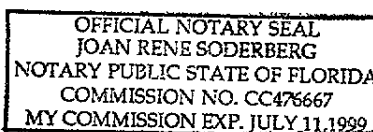
