ARTICLES OF INCORPORATION

I, the undersigned natural person of the age of eighteen years or more acting as incorporator of a corporation under the Florida Professional Business Corporation Act (Florida Statute, Chapter 621), adopt the following Articles of Incorporation:

ARTICLE I

The name of the Corporation is Southeastern Investigations, P.A.

ARTICLE II

The address, including street and number, of the principal place of business of the Corporation is 1825 I Street, N.W., Suite 400, Washington, DC 20006. The principal place of business may be changed from time to time by action of the Board of Directors by filing the prescribed form with the State of Florida.

ARTICLE III

The purposes for which the Corporation is organized are to carry on an accounting and consulting business; and generally to perform any and all acts connected therewith or arising therefrom or incidental thereto, and all acts proper or necessary for the purpose of the business. In furtherance of the corporate purposes, the Corporation shall have all of the powers conferred upon corporations organized under the Florida Business Corporation Act.

ARTICLE IV

The name of the initial registered agent of the Corporation is CT Corporation System, whose mailing address is 1200 South Pine Island Road, Plantation, FL 33324. The registered agent may be changed from time to time by action of the Board of Directors by filing the prescribed form with the State of Florida.

ARTICLE V

The aggregate number of shares of stock which the Corporation shall have authority to issue is one thousand (1,000) shares of common stock and such shares shall have a par value of one dollar (\$1.00) each.

ARTICLE VI

The name and mailing address of each person who is to serve as a director of the Corporation until the first annual meeting or until a successor is elected and qualified is James F. Chadbourne III, 1825 I Street, N.W., Suite 400, Washington, DC 20006.

ARTICLE VII

The incorporator of the Corporation is Sidney R. Smith, III, whose mailing address is Kirkpatrick & Lockhart LLP, 1800 Massachusetts Avenue, Washington, D.C. 20036. The powers of the incorporator are to terminate upon the filing of the Articles of Incorporation.
