ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF GMC PROPERTY MANAGEMENT, INC.

Pursuant to the provisions of Section 607.1003, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is GMC Property Management, Inc.
- 2. Article IV of the Articles of Incorporation is hereby amended in its entirety to read as follows:

This corporation is organized for the purpose of transacting any and all lawful business; provided, however, that for so long as Nomura Asset Capital Corporation, or its successors or assigns, shall hold a first mortgage encumbering any of the real property owned by the partnership of which the corporation is the general partner (the "Nomura Loan"), the business purposes of the corporation shall be limited to such activities and operations as are consistent with the mortgage and other loan documents relating to the Nomura Loan, including, without limitation, the ownership and operation of the apartment projects and office building which are located in Jacksonville, Florida, and encumbered as security by the Nomura Loan.

3. The above amendment to the Articles of Incorporation was adopted by unanimous consent of all of the directors and shareholders of the Corporation on December 12, 1997.
