ARTICLE I. NAME

1-1-98

The name of this corporation is JKH CONSULTING, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 1998, and shall have perpetual existence.

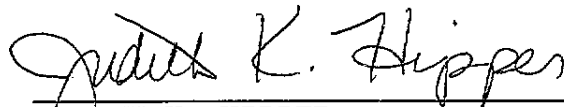
