ARTICLES OF INCORPORATION OF



BYRD'S NEST ENTERPRISES, INC.

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be BYRD'S NEST ENTERPRISES,

INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - INITIAL PRINCIPAL OFFICE

The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such Director or other officer may be entitled.


