
BOARD OF DIRECTORS:

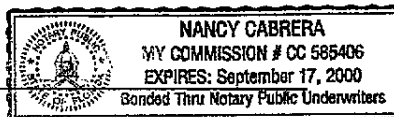
