The purpose of this letter is to apply for your special consideration to the following:

On 11/12/97 I applied for the Registration of my small business and to that effect corresponding "Articles of Incorporation" were filed with you under the above Document Number.

However, due to a clerical mistake in Articles of Incorporation there was a transposition of numbers in my business address, which was not then detected. For that reason my business was registered by you with the address of 1415 San Ignacio, when the correct address should be 1514 San Ignacio.
