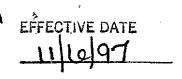

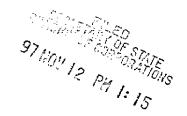

ARTICLE I Name

The name of the corporation is VWS GROUP, INC.

ARTICLE II Duration

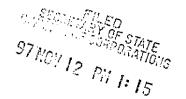
