ARTICLES OF INCORPORATION

Profesor Cali, Inc. A Florida For Profit Corporation

THE UNDERSIGNED for the purposes of forming a corporation under the Florida General Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE NAME

The name of this corporation is Profesor Cali, Inc.

ARTICLE TWO DURATION

The term of existence of the corporation is perpetual.
