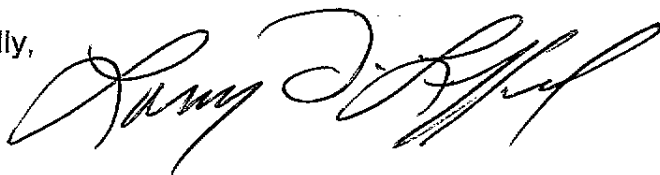

**ARTICLE I**

The name of this corporation is LEFFEL ENTERPRISES, INC.

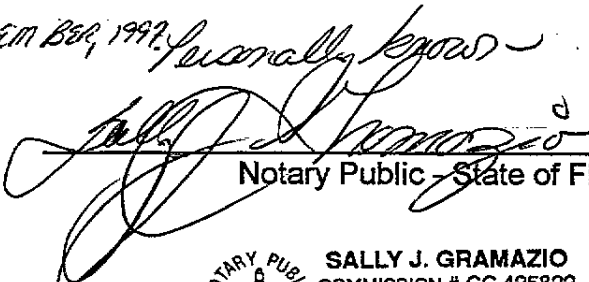
