ARTICLES OF INCORPORATION OF

PAMELA STEARNS, M.D., P.A.

EFFECTIVE DATE

The Undersigned, desiring to organize a professional service corporation for the purposes hereinafter stated, pursuant to the laws of the State of Florida, hereby certificates as follows:

ARTICLE I

Name

The name of this corporation shall be and is:

ARTICLE II

Purpose

The general nature of the professional services to be rendered by this professional service corporation shall be as follows, to-wit:
