# ARTICLES OF INCORPORATION OF BROTHER'S TRANSMISSION & AUTO REPAIR INC.

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

## ARTICLE ONE NAME
