First: That pursuant to Written Consent of the Board of Directors of said Corporation dated December 23, 1997, acting without shareholder approval pursuant to Section 607.1002 of the Business Corporation Act of the State of Florida, the Directors approved the amendment to the Corporation's Certificate of Incorporation as follows:
