The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles Of Incorporation.

**ARTICLE I - NAME**

The name of this Corporation is USA HOMEBUYERS, INC.

**ARTICLE II - NATURE OF BUSINESS**

The Corporation will provide Purchase and Sale of Personal and Real property and to include all services related to the purchases and sales to the public.

**ARTICLE III - CAPITAL STOCK**

The authorized capital of the Corporation shall be 10,000 shares of common stock at a par value of \$1.00 per share.

**ARTICLE IV - TERM OF EXISTENCE**

This Corporation is to exist perpetually.

**ARTICLE V - PREEMPTIVE RIGHTS**
