**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of DRH & ASSOCIATES, ^{CORP.} under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:
