ARTICLES OF INCORPORATION

OF

The undersigned, for the purposes of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

Name and Mailing Address

The name and mailing address of the corporation is SIRGANY'S, INC., 427 Henley Drive, Naples, Florida 34104.

ARTICLE II

Duration


