#### ARTICLE I - NAME

The name of the corporation is: BJS Properties, Inc.

#### ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 203 South 29th Street, Ft. Pierce, FL 34947.

#### ARTICLE III - DURATION
