## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF 198, INC.

1. The following amendment to Article 6 of the Articles of Incorporation, is adopted by the undersigned as the initial and sole Incorporator of the Corporation on December 1, 1997, in the manner prescribed by Sections 607.1001, 607.1005 and 607.1006 of the Florida Business Corporation Act and prior to issuance of shares in said Corporation:

## Article 6 - SHARES (CAPITAL STOCK)

This Corporation is authorized to issue 50,000 shares of Voting Common Stock.
