The undersigned, as sole incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is MASTERPIECE FLOORS, INC.

**ARTICLE II - COMMENCEMENT OF EXISTENCE AND
DURATION**

The date of commencement of the existence of the corporation shall be upon the filing of these Articles and the corporation shall exist perpetually.

ARTICLE IV - PURPOSE

This corporation is organized for the purpose of providing carpet cleaning services and for any other lawful purposes.

ARTICLE V - CAPITAL STOCK

This corporation shall have one class of shares, designated as "common shares". The number of shares of stock that this corporation is authorized have outstanding at any one time is: one thousand and no/100 shares. The shares shall have no designated par value. ARTICLE VIII - INITIAL DIRECTORS

The management of the corporation shall be carried out by a Board of Directors.
