NAME

The name of this corporation is J.V. SERVICE STATION CORP., and its initial place of business shall be located at:

ARTICLE II
DURATION

This corporation's existence shall be effective and commence upon the filing of these Articles of Incorporation and shall continue in perpetuity.

ARTICLE III
PURPOSE



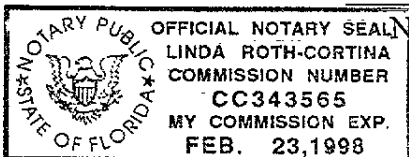


