**ARTICLES OF INCORPORATION  
OF

The undersigned natural persons of the age of eighteen years (18) or more for the purpose of performing a corporation under The General and Business Corporation Law of Florida adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation is:

**FLORIDA CASH ADVANCE, INC.**

**ARTICLE II**

The address, including street and number, if any, of the corporation's initial principal office in this state is:

**ARTICLE III**

The corporation shall only authorize and issue One Thousand (1000) shares of One (1) class of common rating stock at One Dollar (\$1.00) par value per share.

#### ARTICLE VI

The number of shares of common stock to be issued before the corporation shall commence business is One Hundred (100), and the consideration to be paid therefore and the capital with which the corporation shall commence business is the sum of One Hundred Dollars (\$100.00), all of said One Hundred (100) shares having first been duly subscribed by the undersigned incorporator(s) and paid up in cash at the rate of One Dollar (\$1.00) per share, which said sum is in the hands of the undersigned subscriber(s) and incorporator(s).

#### ARTICLE VII

The number of directors to constitute the Board of Directors is One (1). Thereafter, the number of directors shall be fixed by, or in the manner provided in the By-Laws. Any changes in the number of directors will be reported to the Secretary of State within Thirty (30) days of such change. The property and business of the corporation shall be managed and controlled by the Board of Directors.

#### ARTICLE VIII

The duration of the corporation is perpetual.

ARTICLE IX

The corporation is formed for the following purposes: to operate a credit services/small loan business, provide related lending services, and to engage in any lawful acts or activities for which corporations may be organized, and to exercise all the powers permitted by, and to possess and enjoy all rights and powers now or at any time hereinafter may be granted to or exercised by a corporation under the laws of the State of Florida.

ARTICLE X

The power to make, alter, amend or repeal the By-Laws of the corporation shall be nested in the Board of Directors.
