#### ARTICLE I

Name: The name of this corporation is JOALI INVESTMENTS, INC..

The address of the principal office of this corporation shall be

#### ARTICLE II

<u>Duration</u>: This corporation shall have perpetual existence.

## ARTICLE\_III
