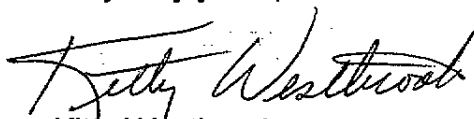

**ARTICLES OF INCORPORATION**

**OF**

**A & R CITRUS HARVESTING, INC.**

The undersigned, acting as Incorporator's to these Articles of Incorporation, of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I**

**NAME**

The name of the Corporation is A & R CITRUS HARVESTING, INC.

**ARTICLE 11**

To own and operate a citrus harvesting business.

To carry on any business whatsoever that this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interest of this corporation, and to have and to exercise all powers conferred by the laws of the State of Florida on corporations formed under the laws pursuant to which and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be amended, and to do any and all things herein above set forth to the same extent and as full as natural persons, firms, associations, or corporations, and in any part of the world.

The foregoing statement of purposes shall be construed as statement of both purposes and powers, shall be liberally construed in aid of powers of this corporation, and the powers and purposes stated in each clause shall, except where otherwise stated, be in no wise limited or restricted by any term or provision of any other clause, and shall be regarded no only as independent purposes, but the purposes and powers stated shall be construed distributively as each object expressed, and the enumeration as to specific powers shall not be construed as to limit in any manner the aforesaid general powers, but are in furtherance of, and in addition to and not limitation of said general powers.

### **ARTICLE III**

#### **CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 1,000 shares of common stock, each share having a par value of \$2.00. Said authorized shares shall be voting shares.

Authorized capital stock may be paid for in cash, services or property at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting.

### **ARTICLE IV**

#### **INITIAL CAPITAL**

The amount of capital with which this corporation shall begin business is \$2,000.00.

## **ARTICLE V**

### **TERMS OF EXISTENCE**

This corporation shall have perpetual existence.

## **ARTICLE IV**

### **ADDRESS**

The initial street address of the principal of this corporation is to be at 3362 Schontag Road, Wauchula, Florida 33873. The Board of Directors from time to time designate such other address and place for the principal office of this corporation as it may seem fit.

## **ARTICLE VII**

### **REGISTERED AGENT**

In pursuant of Chapter 48.091, Florida Statutes, the following is submitted in compliance with said Act:

That A & R CITRUS HARVESTING, INC., desiring to organize under the laws of the State of Florida, with its principal office in the City of Wauchula, County of Hardee, has named ANNIE LOUISE REDDING, located at 3362 Schontag Road, Wauchula, Florida 33873, as its agent to accept service of process within the State; That the Registered Agent's

home address is 3362 Schontag Road, Wauchula, Florida 33873.

## **ARTICLE VIII**

### **DIRECTORS**

This corporation shall have one (1) Director initially. The number of Directors may be increased or diminished from time to time by the by-laws but shall never be less than one (1).

## **ARTICLE IX**

### **INITIAL DIRECTORS**

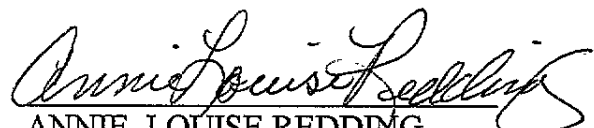
