**ARTICLES OF INCORPORATION
OF
STEVEN FEIN INTERNATIONAL, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is Steven Fein International, Inc. (hereinafter called the "Corporation").

**ARTICLE II
MAILING ADDRESS**

The mailing address of the Corporation is 3301-B NW 2nd Avenue, Miami, Florida 33137.

**ARTICLE III
CAPITAL STOCK**

The number of shares of stock that the Corporation is authorized to issue is one thousand (1,000) shares of common stock, par value \$1.00 per share (the "Common Stock"). 
