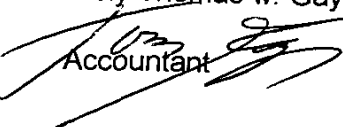
The annual report for Sam & Rosie ,Inc. had been origilanlly filed on Feb. 22,2000.
