**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
FLORIDA COMMUNITY CANCER & IMAGING CENTERS, P.A.**

Pursuant to the Florida Business Corporation Act, **Florida Community Cancer & Imaging Centers, P.A.**, a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

**ARTICLE I
Name, Address and Registered Agent**

1.1. **Name and Address.** The name and address of the professional corporation shall be Florida Community Cancer Centers, P.A. ("Corporation"), 101 N. Starcrest Drive, Suite 200, Clearwater, Florida 33765.


