ARTICLE I--NAME

The name of this corporation is SMOKEY'S ENTERPRISES, INC.

ARTICLE II--DURATION

This corporation shall exist perpetually.

The power to adopt, amend or repeal by-laws of this corporation shall be vested in the members.


ARTICLE XI--INDEMNIFICATION
