## ARTICLES OF INCORPORATION 97 NOV 13 AM 9: 41 OF OUALITY CARE REHAB OF FLORIDA, INC. TALLAHASSEE, FLORIDA

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

#### ARTICLE I. NAME.
