**ARTICLE I.  
CORPORATE NAME.**

The name of this corporation is FLORIDA INMATE TRANSPORTATION, INC.

**ARTICLE II.  
PRINCIPAL OFFICE.**

The principal place of business and mailing address of this corporation are 602 N. Main Street, P.O. Box 650, Cross City, Florida 32628-0650.

**ARTICLE III.  
CAPITAL STOCK.**

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000,000.

**ARTICLE IV.  
INITIAL REGISTERED AGENT AND OFFICE.**

**ARTICLE V  
CORPORATE POWERS.**

The corporation shall have all the rights and powers now or subsequently conferred on corporations by the State of Florida.

#### **ARTICLE VII DIRECTORS.**

Florida Inmate Transportation, Inc. is to be managed by a board of directors. The number of directors constituting the initial board of directors is two(2) and the name and address of the initial directors are:

The initial directors shall hold office until their successors are elected and qualified as provided in the bylaws. The number of directors set forth in these articles of incorporation and constituting the initial board of directors shall be the authorized number of directors until that number is changed by a bylaw duly adopted by the shareholders.

#### **ARTICLE VIII COMPENSATION.**

Each member of Florida Inmate Transportation, Inc. shall receive a salary for the services he performs in an amount to be determined by the board of directors. In addition, the board of directors shall have the power to declare dividends on the shares of this corporation, payable out of its earnings, and any such dividend declared must be pro-rata based upon the number of shares owned by each member.

#### **ARTICLE IX TRANSFER OF STOCK.**

The shareholders of Florida Inmate Transportation, Inc. shall have the power, through the by-laws to regulate the transfer of shares in the corporation, either upon the admission of new shareholders or upon the death, disability or resignation of a current shareholder.

#### **ARTICLE X BYLAWS.**

The initial directors shall submit the proposed bylaws to the shareholders at a meeting to be held for that purpose not more than ninety (90) days following the issuance of the Certificate of Incorporation. Following the adoption of bylaws by unanimous vote of the shareholders, the internal affairs of the corporation are to be regulated and managed in accordance with the bylaws.

**ARTICLE XI  
DISSOLUTION.**

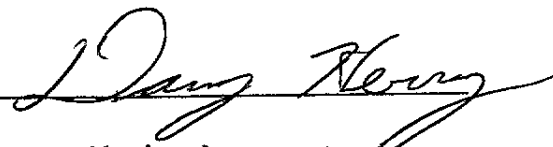
Florida Inmate Transportation, Inc. may be dissolved at any time (1) by written consent of the majority of the shareholders; or (2) on the affirmative vote of the holders of at least two-thirds of the outstanding shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro-rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by the shareholders.

**ARTICLE XII**

These articles of incorporation may be amended, altered, changed, repealed, or added to by majority vote of all shareholders and all rights conferred on stockholders herein are granted subject to this reservation.

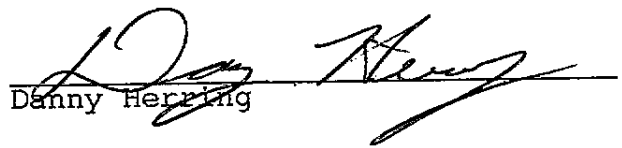
