- FIRST:** The name of the corporation is C & D AUTO SALES, INC.
- SECOND:** The period of its duration is Perpetual
- THIRD:** The purpose(s) for which the corporation is organized are To operate a used auto sales lot and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes."
