ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is TROPICAL HEAT REFRIGERATION  
& AIR CONDITIONING SERVICES CORP.

ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States and of the State of Florida.


