ARTICLES OF INCORPORATION

OF

ARTICLE I. NAME

The name of this Corporation is ABBOTT PUBLISHING, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE VI. COMPLIANCE WITH SECURITIES ACT
