WE, THE UNDERSIGNED, do hereby submit to Incorporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of corporations for profit, the Corporation named in Article I below:

ARTICLE I, NAME

The name of this Corporation shall be:
