**ARTICLES OF INCORPORATION
OF

The undersigned subscribers to these Articles of Incorporation are natural persons competent to contract and do hereby associate themselves to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is Alpha Career Counseling, Inc.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have is SIXTY SHARES, with no par value.

ARTICLE IV

This corporation is to exist perpetually.




ARTICLE X

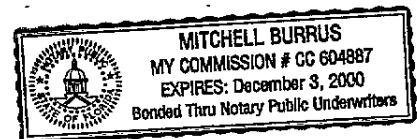
