ARTICLES OF INCORPORATION  
OF  
MIDWAY IRON AND METAL, INC.

ARTICLE I - NAME

The name of this corporation is MIDWAY IRON AND METAL, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III

This corporation was organized for the purpose of transacting any, or all, lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock in this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered office is 312 East Geneva Street, Ocoee, Florida 34761, and the initial registered agent of this corporation at that address is ROBERT H. WALLICK.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have two Directors constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the by-laws;

however, there shall never be less than one director nor more than five. The name and the addresses of the initial Board of Directors of the corporation are:

The corporation shall indemnify any Officer or Director or any former officer or director to the full extent permitted by law.

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.
