ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation is UNI-EXPORT SERVICES, INC..

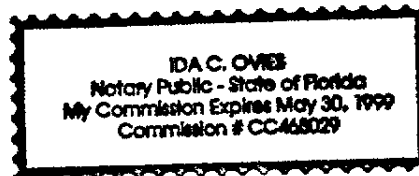
