## ARTICLES OF INCORPORATION OF JIM JOHNSON, INC.

ARTICLE I. NAME: The name of the corporation shall be JIM JOHNSON, INC.

**ARTICLE II. ADDRESS:** The principal place of business of this corporation shall be: 7338 South Tamiami Trail, Sarasota, Florida 34321.
